## FOR IMMEDIATE RELEASE

**MANCHESTER, CT-** As of April 13th, 2020, The State of Connecticut announced an additional 525 Connecticut residents tested positive for COVID-19, bringing the total of positive cases in Connecticut to 12,035. According to the latest data from the state's Department of Public Health (DPH) more than 41,220 tests have been conducted statewide, 1,654 Connecticut residents are currently hospitalized and there have been a total of 554 fatalities. In Hartford County, currently 333 people have been hospitalized and in the Town of Manchester there have been 136 reported positive cases.

It is critical that Manchester residents continue to follow public health official guidance to “flatten the curve” and adhere to social distancing guidelines. The Town of Manchester continues to take proactive measures and provide essential services to keep the community safe.

“As we continue to practice social distancing to flatten the curve, it is important that if you are feeling symptoms to get pre-screened and tested if necessary. This week Manchester and PhysiciansOne Urgent Care have teamed up to provide telehealth pre-screening visits and a Saturday drive-thru testing clinic to provide opportunities and easier access to the community at large. As a reminder:

- All Town of Manchester buildings and administrative offices will be closed indefinitely to the public except for appointment only services. Essential services will continue.
- All public parks are closed to group activities indefinitely. Passive recreation that adheres to social distancing protocol is allowed.
